**Sub: Request to take immediate steps for addressing the missing and anomaly cases occurred in the recent JTO(T) to SDE(T) Promotion Transfer Order –reg:**

Ref: (1) BSNLCO-PRII/13/11/2020-PERS-II Dated 8th July 2021

(2) KRLCO-11/20(3)/4/2020-HR AND ADMN Dated 8th July 2021

Kindly refer to the letters cited above, related with the recent promotion orders to the cadre of SDE (Regular) against 67% seniority-cum-fitness quota. In this promotion order, two of our executives working in Kerala Circle viz., Sri. Jessin Hassan K.P.(HR No: 201002323) and Sri. Arun kumar T.A. (HR No: 201002307) were erroneously left out, where their juniors as per the seniority were promoted and they joined as SDE (Regular). In addition, four executives of Kerala Circle viz., Sri. Sajith A. (HR.No: 200904899) and Smt. Ancy T.J. (HR.No:200901641) were promoted and posted in BBNW Circle mistakenly. Sri. Anoop R.V. (HR.No:201002368) and Sri. Harikrishnan S.(HR.No:201002120) who are recently transferred to Kerala circle are mistakenly shown as part of Tamilnadu circle in the Final AIEL-2. As already Corporate Office had issued promotion orders and posted the executives on "as is where is" basis, kindly intimate to Corporate Office and to address these issues by incorporating the above.

Some of the executives' names viz., Sri. Ani V.S. (HR.No:200203828), Sri. Prabhath K.P. (HR.No:200200428), Sri. Navas (HR.No:200204627), Sri. Noushad Poyilil (H.R.No: 200205478) who were working as SDE (Regular) from the year 2009 against 25% Limited Departmental Competitive Examination (LDCE) vide BSNL Corporate Office Promotion order No.1-14(Postings)/2008-Pers-II dated 03/11/2008 also seen in

the recent promotion order, which is a clear-cut erroneous mistake and in turn against the BSNL Corporate Office Order No. BSNLCO-PRII/12(11)/1/2020-Pers.I dated 12.10.2020.

We request Circle Administration to address these issues with BSNL Corporate Office to correct the mistakes that have crept into the HR details of these executives and to follow-up the cases till they are issued with promotion order by clearing these mistakes.
