Sir,

We would like to submit the following for your information and kind consideration.

Kindly recall the discussions we had with your goodself on the above subject and it was assured that request of those who are completing 2 years of stay in the SSA will be considered and all the case up to September will be cleared in this month itself. But it is reported that the case of those who were transferred on long stay basis only is under consideration which is really disheartening and demoralizing to those executives particularly waiting for more than 10 year to join their family.

For example the following Executives have completed their 2 year service at various BAs and waiting for transfer to their home town after their service in other circle for more nearly 10 years.

All the above Executives were joined in Kerala Circle on Rule 8 in the month of August 2016 and have completed 2 year service in their respective BAs. They were transferred to Kerala Circle only after servicing more than 8 years in the recruited circle though they were eligible for transfer after 5 years. At the time of their posting in Kerala Circle, there was some shortage of Executives at few of the BAs particularly in Malappuram and Kollam. So Management has posted the Rule 8 JTOs to shortage BAs like Malappuram and Kollam and as a responsible Association we also co-operated with such postings. Now the situation has entirely changed with the posting of more than 350 newly recruited JTOs in Kerala Circle during the last 2 years and at present there is no shortage in any of the BAs in Kerala Circle. Besides some of the Rule 8 and mutually transferred JTOs joined recently in Kerala Circle were posted in their home town itself.

In these circumstances, we humbly request your good self to kindly consider the transfer request of all executives completed 2 years and in particular the case of above mentioned Executives to their home town at the earliest as they have worked for more than 10 to 14 years away from their home town .
