Sub : Appointment of Junior Accounts Officers on Probation under 40% quota consequent on completion of 4 Week's Phase I Induction Training – reg.

The following 53 candidates (out of total 55) who have been declared to have passed the JAO Part II Competitive Examination (40% quota) held in December 2012, and in accordance with the results as conveyed vide CGMT, Trivandrum No.AGM(R&E)/CON/JAO-40%/Result dated 24.06.2013 and 06.07.2013 and undergone 4 weeks training with effect from 29.07.2013, as per orders in CGMT, BSNL Kerala Circle No.ES/22-3/2012-2013/28 dated 23.07.2013 and allotted to Kerala Circle as per BSNL Corporate Office, New Delhi No.4-42/2011-SEA dated 6.8.2013 and (2) No.4-42/2011-SEA dated 14.8.2013 and posted as per this office letter of even No.84 dated 22.08.2013, on successful completion of JAO Phase I training, are appointed as 'JAO on Probation' provisionally in BSNL in the IDA pay scale of Rs.16400-40500, and stand posted to the Offices/Units noted against them. This appointment is with effect from 26.08.2013 or from the date of assumption of duties whichever is later.

Further, in respect of the candidates whose result status is provisional, this order of appointment is subject to the outcome of the OA No.1144 of 2012 filed by Shri Sivan and others before Hon'ble CAT Ernakulam and direction of any other OA/Petition on the subject/matter.

2) The appointment is on provisional and on purely temporary basis and subject to the terms and conditions laid down in Recruitment Rules of JAOs in BSNL. They will be governed by all the relevant rules and orders as issued by Corporate Office, BSNL from time to time.

3) The appointee will be on probation for a period of 2 years and if during this period his/her work and/or conduct is/are found to be unsatisfactory, he/she will be reverted to his/her substantive grade.

4) The appointment carries with it the liability to serve in any part of Kerala Telecom Circle and also be liable for field service in any part of India in times of War/National Emergencies. The appointees who have not completed the age of 40 years, if so required, will be liable to serve in the Territorial Army subject to the provisions of Section 6-A of the Territorial Army Act, 1948 and the rules made there under.

5) JAO on probation has to undergo training, as may be scheduled and intimated by CGM NATFM, Hyderabad/Corporate Office, New Delhi from time to time within the total probation period of two years. He/she will earn his/her first increment only on completion of one year and after successful completion of the Second Module Training. He/she will be eligible to earn his/her second increment only on successful completion of the remaining third module training successfully during the second year of probation.

6) The inter-se-seniority will be based on the overall performance/marks obtained by all qualified candidates of this examination in all three phases of induction training.

7) In case the appointee fails to comply with the terms and conditions mentioned above, the appointment as 'JAO on Probation' will be terminated forthwith, without any notice.


