- (2) Formal appointment orders will be issued separately.
- (3) On Posting and on joining as 'JAO on probation' the pay will be fixed in the IDA pay scale of Rs.16400-40500(provisional) as per PAT Branch of Corporate Office, New Delhi No.1-50/2008-PAT (BSNL) dated 5.3.2009.
- (4) JAOs on probation will have to undergo training, as may be scheduled and intimated by CGM NATFM, Hyderabad/Corporate Office, NewDelhi from time to time within the total probation period of two years. They will earn their first increment only on completion of one year and after successful completion of the Second Module training. They will be eligible to earn their second increment only on successful completion of the remaining third module training successfully during the second year of probation.
- (5) The inter-se-seniority will be based on the overall performance /marks obtained by all the qualified candidates of this examination in all the three phases of induction training. *CGM*, NATFM, Hyderabad is requested to give full feedback in this regard on or after completion of their JAO Phase III induction training for taking further necessary action at this end.
- (6) In case any candidate fails to comply with the terms and conditions mentioned above, the appointment as JAO on probation' will be terminated forthwith, without any notice.
- (7) Officials will not bring/attempt to bring any political or other outside influence either directly or through the relatives for the change of Circle/Station of posting upon any superior authority. In case of any such influence, they will attract the provisions of Rule-5 of BSNL CDA Rules 2006 and action will be taken accordingly.
- (8) The Posting of the candidates are subject to the conditions that no disciplinary/vigilance case is pending against the official. In case any disciplinary/vigilance case of type referred in DOP&T OM No.22011/4-91/Estt (A) dated 14.9.92 is pending against the official or where in respect of the official some punishment like stoppage of increment is current, he may not be promoted and the matter should be taken up with the Circle Vigilance Officer and the same may be intimated to this office for further necessary action.
- (9) The above posing is ordered in the interest of service. The official is eligible for TA/DA as per the guidelines issued by BSNL, vide letter No.19-27/2002-L&A (Part) dated 15/04/04.
- (10) BSNL reserves the right to withdraw this offer or terminate the appointment of any candidate or candidates, without assigning any reason, whatsoever.
- (11) The provisional posting order is further subject to final outcome of various court cases pending before Hon'ble CATs/High Courts.
- (12)It should be ensured that these JAOs must not be posted to CSCs and must be deployed in core functions /OS pursuance/OGB/ICB reconnection exercise etc.
- (13) Necessary charge report may be forwarded to all concerned.
