**Sub:- Rule-8 Transfers of Kerala from other Circles to Kerala.**

Respected Sir,

We would like to bring your attention to a most important HR issue related to the JTOs posted Outside Circle and have been working there for more than 6 to 12 years and more.

Being the leading Landphone owned Circle in BSNL, we are facing acute shortage of manpower in Executive Cadre. As per the present statistics, we are handling the operation of the Circle with only 40% of JTOs. Even though we are generating more than 10% of the total revenue of BSNL, it is very unfortunate to see that, we don't have enough man power to handle the field requirement. We are having more than 1300 Exchanges, 5400 BTSs, 2000 Node Bs, nearly 80 BSCs, nearly 20 RNCs, and many vital nodes like MSCs, TAXs, NGN Switches, Broadband NOCs, Radio Planning, IN, OMC-R, OMC-S and above all the most important asset as 24 Lakh Land Line and nearly 10 Lakhs of Broadband connections.

For managing this big network, we having only 1000 JTOs in the Circle. On enquiry it is come to know that there are lot of JTOs working outside who are the natives of Kerala and have requested to get a transfer to Kerala under Rule-8. Some of the names are listed below. We believe that there are JTOs working in many circles more than listed below who are already requested to get a transfer to Kerala. Since we are a profit making circle, and looking forward to bag a lot of business opportunities, and also we are well set for increasing our revenue for more than 10% for the next FY, please intervne with the CGMs of all Circles to get maximum number of JTOs under Rule-8. This is a big opportunity now since there are a lot of postings are being done all around the circles since many are under training for the promotion to JTO cadres.
