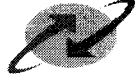

Sub: Promotion of JTOs to the grade of SDE (Telecom) in BSNL against 67% seniority-cum-fitness quota (promotion quota) – reg.

In pursuance of BSNL Corporate office letter No. 2-3/2018-Pers.II dated 15/6/2018, the following JTOs of BSNL in the enclosed Annexure, who are promoted as SDE(Telecom) against 67% Seniority-cum-fitness Quota (Promotion Quota) and allotted to Kerala Circle are hereby posted as SDEs(Telecom) from the date they assume charge of the higher post and until further orders in the IDA pay scale of Rs.20600-46500 and posted to the under mentioned BAs/Units with immediate effect provided that,

- i. They have been absorbed in BSNL on permanent basis;
- ii. No disciplinary/Vigilance case is pending against him/her and no VC is withheld in terms of instructions contained in GOI (DoP&T) OM No:22011/4/91-ESTT(A) dt. 14-9-1992.
- iii. The currency of any penalty against the officer is over; or
- iv. The officer is not on deputation to any other organization.
- v. The officer has not retired on the date of issue of the order
- vi. The officer has not resigned from the BSNL on the date of issue of the order.
- vii. They have fulfilled the prescribed eligibility of three years regular service as per SDE(T) RRs.

2. The officer is required to join his/her promotional assignment within a period of 40 days (including joining time) from the date of issue of BSNL Corporate office order.

3. In case the officer concerned fails to join the promotional assignment within the prescribed period of 40 days, the officer should not be allowed to join the post thereafter. In such a case, the promotion order shall become inoperative and the matter shall be reported to this office for intimating Corporate Office.

4. The leave, if any, requested by the officer, who has been posted on promotion, should not be allowed. If any officer desires leave, he/she can apply for leave to new place of posting under whom he/she has been posted only after joining the new assignment. The new Controlling officer will sanction leave, if it is considered justified as per norms.

5. Discrepancies , if any regarding Name, Gender, Present Circle etc. in the Annexure may be intimated to this office immediately for issuing modifications/corrigendum.

6. The date on which the above order given effect to may be intimated to this office and accordingly a consolidated report of the officers who have been relieved/have joined their new postings may also be sent to this office to assess relieving and joining status of the promoted officers.

8. The aforesaid promotion order is subject to the final outcome/decision in any lawsuit(s) pending before any court(s) regarding their regulation of seniority etc.

9. The relieving and joining particulars of the officers may be updated by in the ERP .

10. Pay fixation on promotion may be done as per prescribed norms.

These orders are issued for immediate joining of executives on promotion. However , transfer order, if any, will be issued subsequently.
