Subject: **Ballot paper for conduct of 1st membership verification of Executives Association through secret ballot on 16.11.2016 - regarding**


Kindly find enclosed herewith a copy of sample ballot paper indicating the name of Associations participating in the 1st Membership Verification (MV). The names of the Association on the ballot paper have been shown in alphabetical order. A sample of ballot paper is attached herewith.

2. The Circles are to make following necessary arrangement for printing of ballot papers:-

1. Ballot Papers may be printed locally taking due care of secrecy.
2. Each ballot paper shall have a counterfoil as shown in Sample Ballot Paper.
3. The counterfoil and not the ballot paper should be serially numbered as shown in the sample ballot.
4. 30% more than required no. of ballot papers may be printed to account for contingencies of the ballot papers getting inadvertently spoiled or crumpled or torn during handling in the actual process of conduct of MV.
5. Ballot papers shall be printed black and white.
6. Associations have been asked to submit their objections, if any, latest by 18.10.2016. Therefore, the final ballot papers may be printed on or after 19.10.2016 but not later than 21.10.2016.

3. Circles should get the Ballot paper printed and make available to the SSAs latest by 22.10.2016.
