Dear Sir,

First of all, may I congratulate your goodself and other leaders of SNEA in the untiring efforts you have put in for the great achievements the Association could make so far and its continued vigour in getting the dreams of Executives fulfilled.

As your goodself is aware, the BSNL Engineers' Co-operative Society Ltd No. T. 950, Trivandrum, a brain child of the erstwhile JETA (I), has entered into its thirty first year of functioning after rendering fruitful services of three decades to the Engineers' community of erstwhile DoT and BSNL. It is a fact that this is the only Co-operative Society in India run for BSNL Engineers exclusively (for their financial needs) and approved by Government of Kerala and Department of Telecom vide Directorate letter No. 18013/3/87-WL(T) dt. 17.08.1987. Moreover, it has proved the credibility of transactions since its inception, till date. The Society could purchase a valuable property utilising its own funds in the Fort area (*Near to the famous Sree Padmanabha Swamy Temple Area*) to construct its own office complex. Recently, we have received the sanction for construction from the competent authority.

While progressing with these glorious activities, it has been reminded from many corners that more deposits should be accepted by the society from Executives or their near relatives from all over the country to expand its activities on an All India basis, and to fulfil the aspirations of all Executives irrespective of their cadres/ branches etc; eventhough the membership was restricted to Engineers only during its inception.

The amount can be remitted by RTGS/NEFT also in the Account (No.020231202200046) alongwith a request accompanying remittance particulars. The Deposit Certificate will be issued soon on receipt of the same. It is assured that the deposit can be withdrawn by the depositors as and when required.
