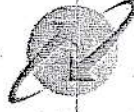

Kind reference is invited to the above letter transferring 10 DEs/AGMs working in Kerala Telecom Circle to West Bengal Circle and this Office letter of even No. dated 18/10/2016 (Copy enclosed for ready reference).

As already mentioned, Kerala Circle is one of the profit making circles of BSNL whose performance is monitored closely by Corporate Office. The Circle is facing acute shortage of DEs/AGMs. Against the sanctioned strength of 382 DEs/AGMs in the Circle only 117 regular DEs/AGMs are working as on date and 265 posts, which is more than 69% of sanctioned posts are lying vacant. Due to acute shortage, the available DEs/AGMs are holding more than two charges which includes looking after DEs also.

During the year 2016 already 22 No. of DEs have been transferred to other Circles from Kerala without substitutes. To add more, many of the officers who were posted to Kerala Circle from other Circles on promotion to DEs are being transferred on completion of 2 years tenure period.
