Sub:- To correct the injustice meted out to the JAOs of 2013 Batch reg:-

Sir,

We would like to bring the following for your kind attention and consideration.

In Kerala Circle, JAO Part-II Internal Competitive Examination (40% Quota) was held on December 2012 for the 101 notified vacancies. Out of this 101 vacancies, 61 vacancies were the carried over vacancies from the year 2010. However, the results were declared for only 40 vacancies as the remaining vacancies were withheld due to the case pending with the Hon. Supreme Court.

Some of the candidates who passed the 2012 Examination approached the Hon. CAT, Ernakulam and the court directed to declare the results of the withheld vacancies and send them for training.

As per the court directions 34 of the eligible candidates were sent for Phase I training at RTTC, Trivandrum. However they were posted as Officiating JAOs. Again the candidates approached the court for getting a direction to post them as permanent JAOs as such they were posted as JAO on 22-3-2016.

The same situation arised in Tamilnadu, Maharashtra, Bihar and Assam Circles. However, all the carried over vacancies from the year 2010 were filled in those Circles in 2013 itself. Unfortunately in the Kerala Circle, the carried over vacancies have not been filled on time, there by making the eligible candidates wait for 3 valuable years to getting their posting.

Now a precarious situation has been brewing out, as those JAOs who were posted in the year 2013 got promoted to Accounts Officers in the month of June 2018. Unfortunately the same batch JAOs who were posted in the year 2016 were rejected, not only their eligible promotion to Accounts Officers but also their inclusion in the gradation list. If they had been given the eligible training and posting along with the 40 candidates they would have got the promotion to Accounts Officers in the month of June 2018 itself. The training and posting were delayed due to the administrative laxity and justice was denied to the above mentioned 34 candidates.

In this context we humbly request your good self that necessary instructions may be given to the concerned to include these 34 candidates in the gradation list in proper place and their eligible promotion may be given at the earliest.
