1	N.Sreekandan	MRX	TVM	He and his spouse are undergoing Infertility treatment at TVM. Now the doctor advised a surgery for his wife in connection with the treatment. After the surgery Shri.Sreekandan's presence is inevitable at his home town for the success of the treatment. Moreover he has worked outside Kerala for 8 years as JE at Tamilnadu Circle
2	Dhanesan K C	MRX	KTM	He has worked as JE in Maharashtra Circle for 8 1/2 Years. Within few years after getting Rule 8 to Kerala Circle he was selected as JTO and posted to Malappuram.
3	Nisar K A A	MRX	ENK	Worked as JTO at Bhandara BA, Maharashtra Circle for 7 years. After getting Rule8 transfer to Kerala Circle he was posted at Malappuram BA
4	Vivek K	MRX	CLT	Worked as JTO at Kodagu, Karnataka for a period 9 Years. After prolonged service at hard areas in Karnataka he got Rule8 to Kerala Circle and posted to Malappuram BA instead of his home town at Calicut.

5	Prasanth P Mohan	PGT	ENK	After 7 years service at Karnataka Circle as JE got Rule 8 to Kerala Circle. Within one year of stay at Home town he was posted to Palghat BA on promotion as JTO through LICE.

The above Officers were posted far away from their hometown during posting on promotion (JTO-LICE) and on joining on Rule-8 transfer. At the time of their posting it was inevitable for the administration to fill the vacant posts at shortage BA's so they were posted away from their hometown. Now the situation has entirely changed. In Kerala circle so far 290 DR JTOs have joined in the financial year 2017-18. At present there is no shortage of JTOs so that the above JTOs can be posted back to their Home BA's without any reliever.
