Sub:- Recovery from pay from JTOs on their superannuation .

As per the letter under reference 1 issued by the BSNL Corporate office which was further endorsed by BSNL Kerala circle vide letter under reference 2 it was ordered as under:

" in view of the order of the P CAT New Delhi ,it has been decided recovery of any amount may not be made from the pay of the officiating JTOs".

But in Ernakulam SSA on superannuation of those JTOs who were earlier officiated as JTOs huge amount is recovered from their terminal benefits purportedly as over payments during the officiating period. Further these officers were not given any notice or details of such recovery . This Association has verified the similar case with Trivandrum BA and it is understood that no such recovery is made from these JTOs (JTOs who have officiated as JTOs from 2007 to till their regularization) on their superannuation. This month three JTOs are retiring from Ernakulam BA: 1. Smt. Susy K P HR No 198214961 , Smt. Latha. R HR .198408047 , Smt. Sasikala. A G . HR No.198408044 and it is reported that huge amount are being recovered from these JTOs from their superannuation benefits which is against Hon. PCAT order which was endorsed by BSNL corporate office as well as BSNL Kerala Circle. It is requested not to effect any recovery from these JTOs in violation of Hon. PCAT order and Corporate office order.
