- 1. The appointment is provisional and on purely temporary basis and subject to the terms and conditions laid down in Recruitment Rules of Junior Telecom Officer in BSNL. He/ she will be governed by all the relevant rules and orders which will be issued by BSNL Corporate Office from time to time.
- 2. The appointment will be on probation for a period of 2 (two) years and if during this period his / her work/conduct is found to be unsatisfactory, his / her service will be terminated forthwith without any notice.
- 3. The appointee carries with the liability to serve anywhere in Kerala Telecom Circle where BSNL may have its organization and in special circumstances anywhere in India. The appointee shall be liable for field service in the time of War and National Emergency. The appointee who has not completed the age of 40 years, if so required, will be liable to serve in

- 4. the Territorial Army subject to the provisions of Section 6-A of Territorial Army Act, 1948 (58 of 1948) and the rules made there under.
- Seniority of the appointee shall be fixed according to the Rules and orders in force. Other conditions of service will be governed by the relevant rules and orders in force from time to time.
- The candidate/s may not bring/attempt to bring any political or other outside influence either directly or through the relatives for the change of Circle/Station of posting upon any superior authority. In case of any such influence, he/she will attract the provisions of Rule-5 of BSNL CDA Rules 2006 and action will be taken accordingly.
- 7. In case the candidate/s fails in the police verification report, the service will be terminated forthwith without assigning any reasons and all the expenditure incurred by BSNL in training etc. will be recovered.
- If the verification reveals that the claim to belong to OBC / SC / ST, as the case may be, is false, the services will be terminated forthwith without assigning any further reasons and without prejudice to such further actions as may be taken under the provisions of the Indian Penal Code for production of false certificate.
- 9. Formal appointment and confirmation in the cadre of Junior Telecom Officer will be given only on receipt of PVR clearance and Caste verification.
- 10. If the candidates wishes to resign from BSNL, he/she shall give a notice in writing 30 days in advance of his/her intention to resign or in default to pay to the BSNL an amount equivalent to one month salary.
- 11. In case any candidate fails to comply with the terms and conditions mentioned above, the appointment as Junior Telecom Officer on probation will be terminated forthwith, without any notice.
- 12. BSNL reserves the right to withdraw this offer or terminate the appointment of the candidate, without assigning any reason, whatsoever.
