



Subject: Introduction of new BB plan 'BBG ULD 1491 EA' for Election purposes in all the Circles - reg.

1. In order to offer Broadband plan to election authorities for smooth conduct of election, following have been decided by the Competent Authority:

a) **To introduce new Broadband plan 'BBG ULD 1491 EA' for Election purpose on Pan India basis in all the circles.**

Details of the plan are as follows:

b) **Modems shall be provided only on prevailing outright purchase charges for such BB connections.**

- The circles shall ensure to comply with all regulatory mechanism.
- The above instructions shall be **effective w.e.f. 16-10-2015 in all the Circles.**
- All other terms and conditions shall remain the same as per earlier circulars.
