<u>CIRCLE</u> <u>TREASURER</u>	Now it is reported that it has been decided by the Administration not to send the candidates those who are granted exemption based on the BSNL corporate office order for the pre appointment training.
G. Premkumar SDE RTTC Trivandrum 9447102277	It may be noted that the appeal made by the exempted candidate to the competent authority to permit them to reappear in the exempted paper (more than 60% marks secured), was rejected and clarified that there is no need to reappear the exempted papers.
	It is also learnt that in other Circles all the candidates those who have cleared the same examination with exemption will be sent for the pre appointment training. (Copy of the order from Tamil Nadu Circle is enclosed). In this connection we are constrained to observe that in legal matters Kerala Circle Administration is more concerned about the interest of the litigants-those who have gone against the BSNL orders rather than protecting BSNL Corporate Office order and the interest of those employees who have complied with the BSNL orders. There is no order from any court restraining the training or appointment of the officers who were granted exemption on the basis of BSNL corporate Office order. It may be noted that if the training is delayed/ denied the candidates from Kerala Circle will become junior to all these candidates and it will affect their entire career.
	In this context, it is requested that all the candidate those who have passed the examination may be send for the pre-appointment training without any discrimination.
