**MISCELLANEOUS APPLICATION FOR IMPEADING FILED UNDER RULE 8 (3) OF THE CENTRAL ADMINISTRATIVE TRIBUNAL PROCEDURE RULES 1987**

**Brief facts of the case:-**

The Original Application was filed seeking to quash Annexure A1, and the permit the Applicant to continue as CGMT, Kerala Circle, Trivandrum.

The impleading petition is being filed by the office bearers of approved trade unions in view of the submission made by counsel for BSNLEU and SNEA seeking impleadment into the Original Application. Except BSNLEU and SNEA, all other trade unions and Executive Associations are in favour of continuance of the Applicant as CGMT, Kerala Circle. All other trade unions are also in preparation for impleadment.

The militancy of the BSNLEU having umbilical connection with CPM and CITU is the reason behind every trouble in the BSNL Kerala Circle in the last few months.

The transfer of 5 persons from the long stay list in the Northern Region annoyed the leaders of those two organizations.

The transfer of a CGMT at the instance of a trade union will set a bad precedent. This may compel the officers to dance to their tune and will take away trade union rights of all other employees. All the miscellaneous applicants are representing registered trade unions with BSNL.

All the allegations against the Applicant in the OA are incorrect.

In the above circumstances, the Honourable Court may be pleased to implead the Miscellaneous Applicants as additional respondents 4 to 7 in the Original Application.

**Reliefs Prayed for:-**

In view of the facts and for the reasons stated above, the Applicant most humbly prays that this Hon'ble Court may be pleased implead the Miscellaneous Applicants herein as additional respondents 4 to 7 in the Original Application.
