In this connection it is to be ensured by all the SSAs/units, where these executives are working that the promotion orders are implemented (i.e. promote the executives ONLY after getting vigilance clearance in the SSA/unit presently working) as per the instructions contained in para 3 of the orders dated 26.06.2018 and furnish a consolidated statement showing implementation status in respect of individual executives to this Office.
