2. On upgradation, the pay of the executives will be fixed under provision of BSNL Corporate Office Order No. 1-50/2008/PAT(BSNL) dated 05.03.2009 & letter No:1-05/2015-PAT(BSNL) dated 19.01.2016. They shall exercise option for fixation of pay as per rules within one month. Before pay fixation, the Unit maintaining the Service Books should verify and confirm that the executives have completed their mandatory training/examination for their earlier upgradation in time. If it is not done within the stipulated period, necessary action may be carried out as per EPP Order and subsequent clarifications issued from time to time.

3. Consequent to upgradation of Pay scale, there will be no change in Substantive Status, designation, duties and responsibilities of the Executives unless any change is ordered in any specific context.

4. The time bound upgradation of IDA pay scale of the executive under the policy is personal to the executive concerned. So no claim whatsoever can be made by comparison on grounds of Seniority, Class, Community, Cadre, Stream etc. Further, except as provided in instant guidelines, no claim will lie on account of any of the other provisions of FRSR in the context of pay scales, pay fixation, substantive status etc.

5. The Executives whose pay is upgraded to next higher IDA Pay scale will have to compulsorily undergo ONLINE learning and successfully complete ONLINE examination for upgradation as prescribed for being eligible for drawal of 2<sup>nd</sup> increment in the upgraded IDA scale. Executives shall register themselves for the mandatory online examination so that they successfully complete within the stipulated period of **two years from the date of issuance** of time bound pay scale upgradation Order. However, the executives who have already retired or retiring within a period of two years from the date of issuance of time bound pay scale upgradation. The executive who fails to successfully undergo the prescribed Online examination will not be eligible for consideration of next pay scale upgradation even if he/she is due for upgradation otherwise. The responsibility of completion of mandatory examination fully rests with the individual executive. Detailed guidelines for the examination is available in the BSNL Intranet vide No. 32-27/04-Trg.[Pt.VII] dated 11.02.2010 & 12.12.2011.

6. The Executives who are of 55 years and above age on the date of their respective upgradation order will have the option to attend one week refresher course as a part of the mandatory training under EPP followed by appearing in online examination at the respective Training Centre. Details for the refresher course are available in the BSNL Intranet vide No. 32-27/2004/Trg (Vol.VII) dated 18.02.2013.

7. The upgradation is further subject to the condition that no disciplinary/Vigilance case is pending against the officers. In case any disciplinary/Vigilance case is pending against the executive or some punishment like stoppage of increment is current, the executive should not be placed in the upgraded by scale and the matter should be reported to this office immediately.

8. In case any discrepancy is observed in the pay scale, due date of Upgradation, completion of mandatory training after previous time bound upgradation etc. against any executive, the Order should not be implemented to such executive and the matter should be intimated to this office.

9. All other terms and conditions shall be governed by O.M. No. 400-61/2004-Pers.I dated 18th January, 2007 and subsequent orders on the subject.
